

EXECUTIVE BOARD NOMINATIONS

The month of October is when we begin the process of having our membership elect Union officers and members of our Union's Executive Board. The elections are held during the last 2 weeks of November. The candidates who are elected normally serve a 2 year term on the Executive Board, but there are 5 vacant seats this year that will be filled for 1 year. Seats will be filled in the order of the number of votes received with 2 year seats being filled before 1 year seats.

The Executive Board currently meets once a month, at 5:30pm every 3rd Thursday of the month. During these meetings the Executive Board considers and acts on a broad range of subjects that are vital to the success of our Union. Executive Board members also are expected to serve on committees that meet between Executive Board meetings and work on projects to benefit the general union membership and work to achieve the goals of MAPE.

The Executive Board's power includes managing the Union's business affairs, hiring of the Executive Director, authorizing concerted activities, lawsuits and any action that may be necessary to further the goals and objectives of our Union. The Executive Board reviews issues with staff that may have an effect on our memberships' well-being. The Executive Board does the general planning for the Union and budgets funds in accordance with that plan. The Executive Board has a crucial role in maintaining and promoting the Union so that the memberships' interests are effectively served.

Any person who has been a <u>member of the Union for at least one year</u> is eligible to serve as a Board Member. On the reverse side of this announcement are the nomination petitions. The petitions require the name and signature of ten <u>members</u> (not fee payers) of the Union. It's a good idea to get more than 10 signatures. If you want to be on the Board, you have three options. 1. You may run to be one of the representatives from your bargaining unit. 2. You may run for an at large seat on the Board. 3. You may run for one of the Officer positions: this year we are having elections for President and Treasurer. Only MAPE members in your Unit may sign a petition for a Unit Director. Any MAPE member may sign a petition for an Officer or an At-Large Director. You may run for multiple seats although you would only be elected to one seat. The Officers have additional duties, as spelled out in the Bylaws, which can be found at newmape.org.
